## HOKR-belyning

Soos alle ander Suid-Afrikaanse universiteite is die NWU tans besig om al hul kwalifikasies en programme te belyn met die Hoëronderwyskwalifikasie-subraamwerk, wat deel van die Hoëronderwyskwalifikasieraamwerk uitmaak. Hierdie projek is die sleutelmeeganisme deur middel waarvan die Universiteit verseker dat akademiese programme oor die drie kampusse heen met mekaar belyn is. Al ons akademiese programme lei tot die toekenning van 'n spesifieke kwalifikasie, wat beteken dat op al die kampusse waar 'n spesifieke program aangebied word, dit in ooreenstemming moet wees met die doel, rasionaal, toelatingsvereistes, leeruitkomstes, kredietstruktuur en assesseringskriteria van die betrokke kwalifikasie. Terwyl die programme by die kwalifikasiestandaarde van die spesifieke kwalifikasie moet hou, word 'n mate van 'n toeweging ten opsigte van die kontekstuele werklikhede op die onderskeie kampusse gemaak. Daar kan op die onderskeie kampusvlakke oor aangeleenthede soos spesifieke assesseringstake en die seleksie van keusemodules besluit word.

### 1. Algemene Toelatingsvereistes

Met inagneming van die Algemene Akademiese Reëls en Fakulteitsreëls soos vervat in die betrokke jaarboeke en met spesifieke verwysing na die Algemene Akademiese Reëls (wat bepaal dat 'n **Nasionale Seniorertifikaat\*** verwerf is en dat daar voldoen is aan die minimum statutêre vereistes vir toelating tot **Diploma\*\*** en/of **B-graadstudie\*\*\*** aan 'n universiteit in die RSA), behou die Universiteit die reg voor om die volgende keuringsmodel toe te pas, aan die hand waarvan kandidate se aansoeke oorweeg sal word.

\* **Om 'n Nasionale Seniorertifikaat te verwerf** moet 'n leerder 'n prestasie van "3" (40-49%) in drie vakke behaal (waarvan een 'n amptelike taal op Huistaalvlak is) en 'n "2" (30-39%) in drie ander vakke op voorwaarde dat 'n portefeulje as bewys van die skoolgebaseerde assesseringskomponent (KASS) van die (sewende) vak wat gedruip is, ingedien word.

\*\* **Universiteitstoelating vir diplomastudies** is 'n NSS, gesertifiseer deur Umalusi, met 'n prestasie van "3" (40-49%) in ten minste vier erkende 20-krediet vakke (Tabel 4).

\*\*\* **Universiteitstoelating tot B-graadstudie** is 'n NSS gesertifiseer deur Umalusi, met 'n prestasie van "4" (50-59%) of beter in ten minste vier 20-krediet vakke wat op die lys van aangewese vakke is (vir die lys van aangewese vakke, sien Tabelle 2 en 3) en hoogstens twee erkende vakke (Tabel 4).

**Toelating tot B-graadstudies aan hierdie kampus** impliseer dat leerders aan die volgende vereistes moet voldoen:

1. Die resultate van ses vakke word gebruik om die APS-telling te bepaal.
2. Die prestasie in Lewensoriëntering (LO) word nie gebruik vir die berekening van die APS-telling nie.
3. Ten minste 'n "4" (50-59%) in vier aangewese vakke behaal het (Tabelle 2 en 3).
4. 'n Prestasie van "4" (50-59%) in die taal van onderrig (Afrikaans of Engels) asook die addisionele taal op HT of EAT, behaal het.
5. Aan die vereiste **Akademiese Prestasieskaal (APS)** vir die spesifieke graad voldoen. Hoewel die NSS uitslae op 'n sewepuntskaal aangedui word, sal persentasies deur Umalusi aan universiteite beskikbaar gestel word vir doeleindes van keuring, beurse, ens. Daarom maak die NWU gebruik van 'n agtpuntskaal. (Tabel 1)
6. Voldoen aan die program- en graadspesifieke vereistes. (Tabel 6)
7. Voorlopige toelating is gebaseer op die resultate wat tydens die finale eksamen in Graad 11 behaal is. Die resultate behaal in die finale eksamen van Graad 12 is egter die deurslaggewende faktor.
8. Aansoeke sluit 30 September.
9. Aansoeke onderhewig aan keuringstoetse, sluit 30 Junie.

Neem kennis dat die Universiteit as gevolg van spesifieke kapasiteitsbepalings hom die reg voorbehou om kandidate vir toelating tot bepaalde studierigtings te keur. Dit beteken dat voornemende studente wat aan die minimum toelatingsvereistes voldoen, nie noodwendig tot die betrokke kursusse toegelaat sal word nie. As gevolg van kapasiteitsbeperkings en die ooraanbod van studente in bepaalde studierigtings, sal studente op grond van hulle skoolastiese prestasie gekeur word vir toelating tot hierdie rigtings.

## HEQC-alignment

As all other South African universities, the NWU is currently busy with the alignment of all its qualifications and programmes with the Higher Education Qualifications sub-Framework, which forms part of the National Qualifications Framework. This project is the key mechanism by means of which the University ensures that its academic programmes are aligned with each other across the three campuses. All our academic programmes lead to the award of a particular qualification, which means that at all the campuses where a specific programme is offered it must be consistent with the purpose, rationale, admission requirements, learning outcomes, credit structure and assessment criteria of that qualification. While programmes must adhere to the qualification standards of the particular qualification, some allowance is made in terms of the contextual realities at the various campuses. Matters such as specific assessment tasks and the choice of elective modules could be decided on at the different campus levels.

### 1. General Admission Requirements

Taking due cognisance of the General Academic Rules and Faculty Rules as contained in the relevant yearbooks and with specific reference to the General Academic Rules (which determines that a **National Senior Certificate\*** is obtained and that the minimum statutory requirements for admission to **Diploma\*\*** and/or **B.degree studies\*\*\*** at a university in the RSA have been complied with). The University reserves the right to apply the following selection model, on the basis of which consideration will be given to candidates applications.

**\* To obtain a National Senior Certificate** a learner must achieve a “3” (40-49%) in three subjects (one of which is an official language at Home Language level) and a “2” (30-39%) in three other subjects provided that a portfolio of evidence in the school-based assessment component (CASS) is submitted in the (seventh) subject failed.

**\*\* University admission for diploma studies.** is a National Senior Certificate (NSC) certified b Umalusi with an achievement of “3” (40 - 49%) in at least four recognised 20-credit subjects (Table 4).

**\*\*\* University admission for B-degree studies** is a National Senior Certificate (NSC) certified b Umalusi with an achievement of “4” (50-59%) or better in at least four 20-credit subjects that are on the list of designated subjects. (For the list of designated subjects see Tables 2 and 3) and at the most two recognised subjects (Table 4).

**Access to this campus for B-degree studies** implies that learners are required to have met the following minimum requirements:

1. The results of 6 subjects are used to determine the APS score.
2. The achievement in Life Orientation (LO) will not be used in contemplating the APS score.
3. Obtained at least a “4” (50-59%) in four designated subjects. (Tables 2 and 3)
4. Obtained a “4” (50%-59%) in the language of instruction (Afrikaans or English) as well as the additional language on HL or FAL level.
5. Comply with the required **Academic Performance Scale (APS)** for the particular degree. Although NSC-results will be expressed on a seven-point scale, percentages will be provided by Umalusi to universities for purposes of selection, bursary grants, etc. and therefore the NWU will make use of an eight-point scale (Table 1).

6. Comply to the programme and degree specific requirements for the particular degree (Table 6)
7. Preliminary admission is based on the results obtained in the final Grade 11 examinations. The results obtained in the final Grade 12 examinations will be the determining factor regarding admission.
8. Applications close 30 September.
9. Applications subject to selection tests, close on 30 June.

**Take cognisance of the fact that, owing to specific capacity constraints, the University reserves the right to select candidates for admission to certain fields of study. This means that prospective students who comply with the minimum requirements may not necessarily be admitted to the relevant courses. Owing to the capacity limitations and the high demand from students for admission to particular fields of study, students will be selected on the basis of their scholastic achievements for admission to these fields.**

## 2. Fakulteitspesifieke vereistes / Faculty specific requirements

### 2.1 FAKULTEIT GEESTESWETENSKAPPE / FACULTY OF HUMANITIES

**Opmerking: Afrikaans en Nederlands**

a) Vir toelating tot Afrikaans: Taal sonder grense (AFLL111) en Afrikaanse en Nederlandse Taal- en Literatuurstudie (AFLL121) word minstens 'n vlak 4 in Afrikaans as huistaal of 'n vlak 5 in Afrikaans as eerste addisionele taal vir graad 12 vereis.

b) Studente wat aan die toelatingsvereistes vir AFLL111 en AFLL121 voldoen, maar tog kommunikasieprobleme ondervind, word verwys na die Voorsitter van die Vakgroep Afrikaans en Nederlands.

**Notice: English**

a) ENLL111 (Academic module): It is strongly recommended that students with a matriculation result of 60% or more in L2, or a result of 50% or more in L1 should choose this course.

b) ENLL 121: To register for the second semester academic module (ENLL121), a student must have obtained a mark of 60% or more for the academic module of the first semester (ENLL111). Students who fail to obtain 60% for their module mark of the first semester (ENLL 111) will be streamed into the service-/ practical module of the second semester (ENLS 122). However, the English subject group retains the right to consider individual cases on merit.

**Opmerking: Sesotho derdetaal**

Studente wat 'n Sothotaal soos Setswana, Suid-Sotho (Sesotho) of Noord-Sotho (Sepedi) as huistaal in die graad 12-eksamen geslaag het of een van die tale as moedertaal het, kan nie vir die derdetaalkursusse van Sesotho (SSCO111, SSCO121) inskryf nie.

**Notice: Sesotho third-language**

Students who passed the Grade 12 Home Language examination in any of the Sotho languages Setswana, South Sotho (Sesotho) or North Sotho (Sepedi), or who have any of these languages as their mother-tongue, may not enroll for the third-language courses in Sesotho (SSCO111, SSCO121).

### 3.2 A-LEVELS

The four subjects (AS Level) must include one subject from Groups 1 and 2 respectively, and two subjects must be passed from two different groups from among Group III, IV or V. A student who passed only three subjects or the Advanced Level (AS Level) may be considered for Senate-discretionary admission
